That means that you will have to **report EVERY TIME YOUR ANIMAL LEAVES YOUR "PREMISE" FOR ANY REASON!** Failure to comply may result **in \$1000 per DAY per ANIMAL with NO EXCEPTIONS.** **The movements WILL BE TRACKED BY A SATELLITE THAT IS ALREADY IN PLACE AND READY TO REPORT YOU for non-compliance!**

- Trailride down a neighbor's bridle path? **REPORT to the Government!**
- Chicken flew into your neighbor's yard? **REPORT to the Government !**
- Horse escaped during the night and traveled your neighborhood? **REPORT to the Government !**
